## The Honda Classic Volunteer Waiver, Release and Indemnity Agreement

The undersigned, having agreed to serve as a Volunteer without monetary compensation at the Honda Classic golf tournament at PGA National Resort and Spa in Palm Beach Gardens, Florida from February 27 – March 4, 2012, in recognition of the fact that volunteering at the Honda Classic can involve inherently dangerous activity including, but not limited to crowd control/security, physical labor, driving cars, shuttles, golf carts or other vehicles, being in the presence of live golf shots, using or volunteering near electronic equipment, and being outdoors in inclement weather, agrees to the terms of the following Release:

1. I, releasor, intending to be legally bound and in consideration for being permitted to serve as a Volunteer at the Honda Classic (such service hereinafter referred to as the "Activity") do for myself, my spouse, children, heirs, executors, administrators, insurers and assigns, hereby release, waive and forever discharge the Honda Classic, Nicklaus Children's Healthcare Foundation, Children's Healthcare Charity, Inc, PGA National Resort and Spa, IGP Management, and their respective officers, partners, directors, employees, representatives, parent companies, affiliates, subsidiaries, insurers, successors and assigns, as well as the manufacturers and distributors of any equipment used in the Activity (the "Releasees"), from any and every claim, demand, action or right of action, of whatever kind or nature, either in law or in equity, arising from or by reason of any bodily injuries or personal injuries known or unknown, death or property damage resulting from, or to result from, my participation in the Activity or any activities in connection with the Activity, whether caused by the negligence, including gross negligence, of Releasees or not.
2. I agree to indemnify, defend and hold harmless the Releasees from any injury, loss, liability, damage or cost Releasees may incur due to my participation in the Activity, whether or not caused by the negligence, including gross negligence, of Releasees or otherwise.
3. I assume full responsibility for the risk of bodily injury, death or property damage due to the negligence of Releasees or otherwise while in or upon PGA National Resort and Spa and while participating in the Activity.
4. I agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Florida, and that if any portion of this agreement is held invalid, it is agreed that the balance shall continue in full legal force and effect.
5. This release, waiver, and indemnity agreement shall be governed by and construed in accordance with the laws of the State of Florida.
6. I hereby consent and agree to the exclusive personal jurisdiction and venue of the Court of Common Pleas of Palm Beach County, Florida, with respect to any legal action or proceeding arising out of or relating to the Activity. Each party hereby waives all rights it has or which may hereafter arise to contest such exclusive jurisdiction or venue of the Court of Common Pleas of Palm Beach County, Florida.
7. I am of legal age and fully competent, and I have carefully read the foregoing waiver, release and indemnity agreement and I understand the contents of the same. If I am not of legal age, my parent or legal guardian has fully read the foregoing waiver, release and indemnity agreement and understands it and understand that I am fully bound by their signature.
